Mr. Gerhard Van Graan - CA (SA) - Managing Director

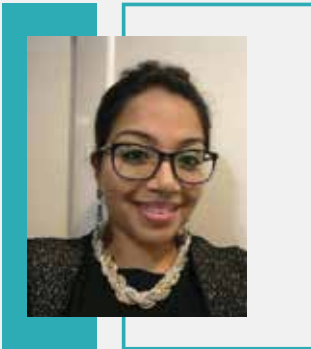
